PRESIDENT'S MESSAGE

Hi Members and Neighbors,

What wonderful, spring-like weather we have been experiencing in these first weeks of February. Take advantage of it while it lasts, for we do not know what March has in store for us.

The Department of Transportation has given us two of the signs we have requested: An "All-Way Stop Sign" at 217th Street and 94th Avenue (by our library) and a "Yield to Pedestrian Sign," 93rd Avenue and Springfield Boulevard, at Our Lady of Lourdes Church. The signs should help to eliminate traffic accidents there.

We welcome Deputy Inspector Paul Piekarski, the new Commanding Officer of the 105th Precinct. We look forward to working with him to help keep our community safe. We will invite him to one of our monthly meetings to express our concerns and seek his advice on combating crime.

The Lawn Litter Bill is now law. We will have the signs you need to enforce this law at this month's meeting. We thank Senator Frank Padavan and Assemblyman Mark Weprin as they were instrumental in getting support for the bill in the State legislature. (Refer to article in the news page.)

We have asked our elected representatives to help us get rid of the monster trucks that park in our community illegally without impunity, especially on Braddock Avenue between 89th and Hillside Avenues. They are hazardous to motorists as they take from 70 to 90 feet of the roadway, and slow and obstruct traffic. They also wear out our local streets. Why should the City subsidize trucking companies by providing free, illegal parking? Why aren't these trucks being ticketed or booted?

The Department of Transportation has approved 221 Street from Braddock Avenue to Winchester Boulevard for conversion to one-way traffic north bound. A JURY DUTY SCAM

A new and ominous kind of fraud has surfaced with the perpetrators claiming that they are jury coordinators and that they are inquiring about why you did not show up for jury duty. They add that there is warrant for your arrest for failure to report for jury duty. When you tell them that you did not receive the notice, they say that they can cancel the arrest warrant if you give them your social security number and date of birth. Don't fall for it. Tell them that if they are legitimate they would already know your social security number and that you will verify it if they tell you what it is. Or just hang up. These scammers try to intimidate and bully people by saying that they are employed by the courts. The FBI and the Federal Court System have issued nationwide alerts about this scam. It has been reported in 11 states, including New York.

CONDOLENCES

Anna Jensen, a longtime member of our civic association, passed away on February 1. LAWN LITTER LAW IN EFFECT

Thanks to widespread support from civic organizations and residents throughout Queens, Senator Frank Padavan's Lawn Litter Law has been enacted. Finally, residents will no longer have to put up with the deluge of unwanted flyers and literature left on their property. The law imposes a civil penalty of between \$250 and \$1,000 on businesses that do not adhere to a sign posted by a resident stating that their advertisements are not wanted. These window signs, provided by Senator Padavan, will be available at this month's meeting. The City has 60 to 90 days to establish rules and regulations in relation to the enforcement of the Lawn Litter Law and to designate an agency to enforce the law. The Lawn Litter Law will help to safeguard our quality of life and security, and promote civic pride.

LIBRARY DAY IN ALBANY

With the purpose of assuring full New York State funding for libraries, the Queens Borough Public Library will once again conduct its annual "Library Day in Albany" bus trip on Tuesday, March 11. Library friends, supporters, and staff will fill chartered buses that will bring Queens residents to their State Senators and Assembly Members to speak with them about the importance of fully funded libraries. The buses will depart from the Central Library in Jamaica, Broadway Library in Astoria, Bay Terrace Library in Bayside, and other sites as needed. A light lunch will be provided.
